For service under this limited warranty, please have available the proof of purchase and the purchase date and location as well as a detailed description of the problem. LIMITATION OF REMEDIES



Read all instructions before using this safe.

IMPORTANT

- Test registered RFID card before closing and locking door.
- Do not Copy the RFID card, Barska is not responsible for any lost or stolen contents.
- Label each registered card after each registration.
- Do not store registered card inside of the key cabinet.
- Short beeping sound means wrong scan.
- The Lock cannot be operated when the battery voltage is low, please check and change the battery if the Low Battery Voltage indicator light is on.
- Keeping and storing management cards in a secure place is recommended, should it be lost, it cannot be replaced, the entire lock will need to be replaced.


Install Battery


CR2450 (not included)

- Step 1: Unscrew battery box on the top of lock.
- Step 2: Remove battery box and insert the battery (CR2450).
- Step 3: Screw back battery box (Short flashes of Red and Green once connected).

RFID Card Type And Function

A. RFID Card Type

Management Card: 1 User
Main Card: Up to 3 Users
Control Card: 1 User


Note: 5 cards are included, additional cards can be purchased from BARSKA if needed.

B. Unlocking and Locking Key Cabinet

To Unlock: Use a registered RFID card to unlock Key Cabinet.

It is possible that the lock is not responding due to a low voltage in the battery, so replace it as soon as possible.

- 1. Use **Management Card**: Scan 4 times to unlock and turn knob clockwise to open the Key Cabinet.
- 2. Use **Main Card**: Scan 1 time to unlock and turn knob clockwise to open the Key Cabinet.
- 3. Use **Control Card**: Scan 1 time to unlock and turn knob clockwise to open the Key Cabinet.



To Lock:

Turn the knob counterwise to lock key Cabinet.

After locking, please always turn the knob clockwise to make sure it's fully locked

Note: The lock might not function properly if the voltage is low. Please replace the battery if the lock won't lock





C. Registering Information

1. Register Management Card

Function: Add or Delete card types and unlock the key cabinet.

The key cabinet comes with a **registered Management** Card. Please use the Management Card to process other card type registration.

If you need to reset the registered Management Card, follow reset the lock procedures.

Registering Management Card (Only 1 User):

Step 1: First take one unregistered card.

Step 2: Next, Scan 1 time, will hear one long beep.

Step 3: To test the registered Management Card, please scan the card 4 times, the key cabinet will be unlocked.

Step 4: Label the card as a Management Card

2. Register Main Card

Function: To unlock the key box cabinet.

Registering Main Card (up to 3 users):

Step 1: First use Management Card scan 3 times and the green LED flash.

Step 2: Next, take the one unregistered card and scan it 1 time, the Main Card is now registered.

Step 3: To test the registered Main Card, please scan the card 1 time to unlock.

Step 4: Label the card as Main Card.

Note:

- To set up additional Main Card users: Repeat the Main Card registration procedure.
- After registering three users, you will not be able to add more to the card and will hear two short beeps to indicate.
- Once the main card has been registered, it cannot be deleted. Under the reset the lock registered card function (See p.8), you can only do this if necessary.

3. Register Control Card

Function: To unlock the key box cabinet

Registering Control Card (1 user):

Step 1: First use Management Card scan 1 time and the green LED flash.

Step 2: Next, take the one unregistered card to scan 1 time, the Control Card is now registered.

Step 3: To test the registered Control Card, please scan the card 1 time to unlock.

Step 4: Label the card as Control card.

Note:

 To register a new Control Card, repeat the register Control Card procedure. The previous Control Card will be invalidated.

Reset The Lock/Delete The Registered Card

(All registered cards will be deleted after this process)

Scan the Management Card 5 times until hearing two beeps and a green LED flash. ALL registered key cards are now deleted, including the Management Card.

Note

 The card scan after this reset procedure will be a Management Card. We recommend immediately registering the management card after deletion of all types of cards.

Questions And Answers

Q: How to recognize whether a Management Card is valid?

A: Scan the card four times, the key cabinet will be unlocked.

Q: The lock does not respond when scanned.

A: Low battery voltage could be the cause, please replace battery.

Q: When you hear the two short beeps

A: This means that the card has been registered or that the maximum number of users has been reached

Q: Can be register if having multiple key cabinet with the same Management Card, Main Card or Control Card to unlock the key cabinet.

A: Yes, you can.

Q: After the door closes in five seconds, the lock does not lock

A: Low battery voltage could be the cause, please replace the battery.
